



National Celiac Awareness Measure Garner Unprecedented Support Industry, Consumers and Policy Makers Back Legislation

The American Celiac Disease Alliance (ACDA) announces unprecedented support for bill by Rep. Nita Lowey recognizing May as National Celiac Disease Awareness Month. The measure also emphasizes the important role dietitians play in helping celiac patients, and urges more funding for celiac research. Major medical groups, pharmaceutical companies, food manufacturers and patient support groups have endorsed the bill.

Alexandria, VA, May 17, 2008 --(PR.com)-- The American Celiac Disease Alliance (ACDA), the unified voice for the most common genetic disorder in the world, today announced unprecedented support for legislation recognizing May as National Celiac Disease Awareness Month. The measure also emphasizes the important role dietitians play in helping celiac patients, and urges more funding for celiac research.

The American College of Gastroenterology, American Gastroenterology Association, American Dietetic Association, and American Osteopathic Association, along with pharmaceutical companies, food manufacturers, and patient support groups have all endorsed the bill. (Complete list provided below).

Celiac disease affects at least one percent of the population, or roughly 3 million Americans, about 97% remain undiagnosed. While classified as a digestive disease, it actually is a multi-system, multi-symptom disorder that affects adults as well as children. Left untreated, celiac disease leads to other serious conditions including osteoporosis, infertility and cancer.

A recent report of the National Commission on Digestive Diseases noted that physicians in the U.S. don't understand that celiac disease is the most common genetic disorder in the world and aren't trained to look for it in patients. There is no cure for celiac disease. The only treatment for this chronic auto-immune disease remains strict adherence to a life-long gluten-free diet.

“Passing H.Con.Res.70 will help raise awareness among the medical profession and the general public,” said Representative Nita Lowey, the bill's sponsor. “Millions of Americans have suffered for years with little understanding from the medical community or lawmakers. We are years behind European countries in dealing with celiac disease. Now is our chance to take a huge step forward.”

Food manufacturers see both the need for and the potential of catering to those with celiac disease. General Mills recently removed barley malt from its 'Rice Chex' cereal to create a safe gluten-free product. The Wall Street Journal estimates revenues for gluten free products will exceed \$1.7 billion by 2010.
